But PVST+ has only 3 port states (discarding, learning and forwarding) while STP has 5 port states (blocking, listening, learning, forwarding and disabled). So discarding is a new port state in PVST+. Background Information802.1D Spanning Tree Protocol (STP) has a drawback of slow convergence. Cisco Catalyst switches support three types of STPs, which are PVST+, rapid-PVST+ and MST. PVST+ is based on IEEE802.1D standard and includes Cisco proprietary extensions such as BackboneFast, UplinkFast, and PortFast. Rapid-PVST+ is based on IEEE 802.1w standard and has a faster convergence than 802.1D. RSTP (IEEE 802.1w) natively includes most of the Cisco proprietary enhancements to the 802.1D Spanning Tree, such as BackboneFast and UplinkFast. Rapid-PVST+ has these unique features: Uses Bridge Protocol Data Unit (BPDU) version 2 which is backward compatible with the 802.1D STP, which uses BPDU version 0.All the switches generate BPDUs and send out on all the ports every 2 seconds, whereas in 802.1D STP only the root bridge sends the configuration BPDUs. Port Roles--Root port, designated port, alternate port and backup port. Port States--Discarding, Learning, and Forwarding. Port Types--Edge Port (PortFast), Point-to-Point and Shared port.Rapid-PVST uses RSTP to provide faster convergence. When any RSTP port receives legacy 802.1D BPDU, it falls back to legacy STP and the inherent fast convergence benefits of 802.1w are lost when it interacts with legacy bridges. Because SwitchC is the root bridge the 2 ports nearest SwitchC on SwitchA (Fa0/1) and SwitchD (Gi0/2) will be root ports (RP) -> B and F are correct.SwitchB must have a root port so which port will it choose? To answer this question we need to know about STP cost and port cost. In general, "cost" is calculated based on bandwidth of the link. The higher the bandwidth on a link, the lower the value of its cost. Below are the cost values you should memorize: Link speed Cost SwitchB will choose the interface with lower cost to the root bridge as the root port so we must calculate the cost on interface Gi0/1 & Gi0/2 of SwitchB to the root bridge. This can be calculated from the "cost to the root bridge" of each switch because a switch always advertises its cost to the root bridge in its BPDU. The receiving switch will add its local port cost value to the cost in the BPDU. SwitchC advertises its cost to the root bridge with a value of 0. Switch D adds 4 (the cost value of 1Gbps link) and advertises this value (4) to SwitchB. SwitchB adds another 4 and learns that it can reach SwitchC via Gi0/1 port with a total cost of 8. The same process happens for SwitchA and SwitchB learns that it can reach SwitchC via Gi0/2 with a total cost of 23 -> Switch B chooses Gi0/1 as its root port. Now our last task is to identify the port roles of the ports between SwitchA & SwitchB. It is rather easy as the MAC address of SwitchA is lower than that of SwitchB so Fa0/2 of SwitchA will be designated port while Gi0/2 of SwitchB will be alternative port. The drawback is that these mechanisms are proprietary and need additional configuration. Alternate and Backup Port Roles These two port roles correspond to the blocking state of 802.1D. A blocked port is defined as not being the designated or root port. A blocked port receives a more useful BPDU than the one it sends out on its segment.Remember that a port absolutely needs to receive BPDUs in order to stay blocked. RSTP introduces these two roles for this purpose.Rapid Transition to Forwarding StateRapid transition is the most important feature introduced by 802.1w. The legacy STA passively waited for the network to converge before it turned a port into the forwarding state. The achievement of faster convergence was a matter of tuning the conservative default parameters (forward delay and max\_age timers) and often put the stability of the network at stake. The new rapid STP is able to actively confirm that a port can safely transition to the forwarding state without having to rely on any timer configuration. There is now a real feedback mechanism that takes place between RSTP-compliant bridges. A route is considered in the Passive state when a router is not performing a route recomputation. The route is in Active state when a router is undergoing a route recomputation. If there are always feasible successors, a route never has to go into Active state and avoids a route recomputation. When there are no feasible successors, a route goes into Active state and a route recomputation occurs. A route recomputation commences with a router sending a query packet to all neighbors. Neighboring routers can either reply if they have feasible successors for the destination or optionally return a query indicating that they are performing a route recomputation. While in Active state, a router cannot change the next- hop neighbor it is using to forward packets. Once all replies are received for a given query, the destination can transition to Passive state and a new successor can be selected.
